AN ORDINANCE OF THE CITY OF RICHMOND, KENTUCKY ACCEPTING THE DEDICATION OF PAVILION WAY AND GOLDEN LEAF BOULEVARD AS PUBLIC WAYS AND CITY STREETS FOR ALL PURPOSES

WHEREAS, the developer of the Pavilion @ Golden Leaf development has completed the construction of Pavilion Way and Golden Leaf Boulevard within that development and the City's public works department has inspected those streets and found them to be acceptable; and

WHEREAS, the developer, as is implicit in the development's plat, has offered to make formal dedication of those streets as public ways and City streets; and

WHEREAS, the Board of Commissioners for the City does accordingly wish to accept such dedication;

NOW, THEREFORE, BE IT ORDAINED that Pavilion Way and Golden Leaf Boulevard in the Pavilion @ Golden Leaf development are each hereby accepted, along the entire length of each, as public ways and City streets for all purposes.
