Mr. Minerich discussed the following items:

1. Sports Fields Positions: The 2 employees that were hired tonight have 10 years expertise in maintaining sports fields.
2. Auditor: The audit team is rapping on-site visit this week and plan on presenting the audit report to the commission on the December 11th meeting.
3. Street Paving: Paving will resume next week
4. Requested Emergency Spending for Sinkhole on Moberly Ave. Mr. Minerich described the sinkhole as a result of the paving trucks on Moberly Ave which discovered the sinkhole as part of the street caved in. The hole is properly covered, however request emergency spending to get the hole fixed as soon as possible. He presented the Allen Company bid at roughly \$50,000.00 which would come out of a stormwater fund.

Commission asked for a vote to allow City Manager to spend funds Emergency Funds to fix Moberly Ave sinkhole with not to exceed \$55,000.00.
